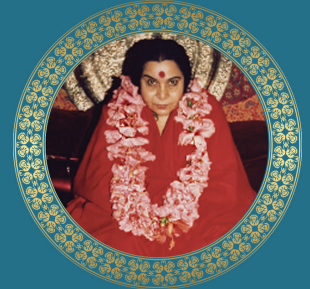

## WILL BEQUESTS TO SAHAJA YOGA

*By leaving a gift in your Will to Sahaja Yoga via Life Eternal Trust Australia you can support the needs of Sahaja Yoga and play a continuing part to support Sahaja Yoga Meditation Australia into the future. It is never too early to start thinking about a charitable gift in your will. Now could be the perfect time to create your legacy.*

## CHOOSE HOW TO DONATE YOUR GIFT

Whole or part of your estate, you can leave your entire estate or any part of your estate to Life Eternal Trust Australia as you feel best expresses your wishes and circumstances.

## PERCENTAGE OF YOUR ESTATE

Not sure how much will be in your estate? You can leave the entire estate or any percentage of your estate as you choose. This means that no matter the value of your estate, the percentage you intend will remain the same.

## SPECIFIC GIFT

A specific gift is a specified sum of money, or particular item(s) or property.

## RESIDUARY GIFT

A residuary gift is one where you give a portion of all of that is remaining in your estate after specific gifts and debts are fulfilled. After you have taken care of loved ones and dependants, you can leave Sahaja Yoga Australia whole or part of what remains in your estate.

## DIRECTING YOUR BEQUEST

You are free to direct a bequest in a Will towards a particular purpose and the Trust will fulfil your request as to a specific Sahaja Yoga purpose, Project or property in Australia. The Trust is bound to direct funds to charitable purposes within Australian only.

## SUGGESTED WORDING FOR INCLUSION IN YOUR WILL

We recommend that you work with a solicitor or Public Trustee to write your Will. You can share this wording with them. When drafting your Will discuss these options with your lawyer that best expresses your wishes, some examples of the inclusion are:
